

TERMS AND CONDITIONS FOR MND VICTORIA EVENTS (PHYSICAL AND VIRTUAL)

You acknowledge that you have read and agree to be bound by these terms upon either submitting your registration to an MND Victoria event or attending or participating in an MND Victoria event.

If you intend on participating in an MND Victoria Event and are under 18 years of age a parent or guardian must read these terms and acknowledge and accept them on your behalf.

By registering for an MND Victoria event, you agree to the following terms and conditions:

REGISTRATIONS

- a. Your registration for an MND Victoria event will be confirmed in writing via email after MND Victoria has received your fully completed online registration, including the registration form and the registration fee (if required) related to your registration. MND Victoria may in its absolute discretion for any reason refuse to accept your registration.
- b. MND Victoria's preferred method of registration is online. If you encounter difficulties with the online registration system, please contact MND Victoria at community@mnd.org.au
- c. By registering for an MND Victoria event you consent to receiving and reading the information about the event. If you have previously unsubscribed from MND Victoria communications, you will be re-subscribed upon registration. The event communication will primarily be via email. Updated information will be posted on the relevant event website by MND Victoria and through social media from time to time. It is your responsibility to check The Great MND Relay website to remain updated on event communications.
- d. To ensure safety this event does have a capacity limit. On the day registrations are not guaranteed to be available. The Great MND Relay can refuse on the day registrations in accordance with the capacity limit and for any reason.

CANCELLATIONS AND REFUNDS

- a. Registration fees are not refundable if you change your mind or are no longer able to participate in an MND Victoria event.
- b. Donations to MND Victoria (including The Great MND Relay and any events run by MND Victoria) are non-refundable if you change your mind.
- c. Fees will not be refunded if you are denied access or removed from an MND Victoria event for any reason.
- d. A registration is not transferable to another person or to a future MND Victoria event without the written permission or consent from MND Victoria
- e. In the instance that MND Victoria events cannot proceed for any reason prior to commencement, Registered Parties will be offered options regarding the paid

registration fee; these options will be communicated through email if this instance occurs.

- f. If the MND Victoria event is cancelled after commencement, Registered Parties will not be offered a refund of the Fee. Cancellation may be for any reason including fire, traffic incident or weather.
- g. All donations to MND Victoria are non-refundable, including (but not limited to) in the event of cancellation, postponement or change of mind.

MND VICTORIA EVENT RIGHTS

- a. MND Victoria reserves the right at any time to:
 - i. change the format, participants, content, location and timing or any other aspect of an MND Victoria event.
 - ii. postpone an MND Victoria event .
 - iii. cancel an MND Victoria event or any part of an MND Victoria event, and will not be liable for any damages, costs, losses or expenses of any kind incurred or suffered by you as a result of or in relation to MND Victoria modifying, postponing or cancelling an event.

YOUR RIGHTS AND OBLIGATIONS AT AN MND VICTORIA EVENT

- a. MND Victoria reserves the right, without any liability, to refuse admission to, or to eject you from an MND Victoria Event, in its absolute discretion, including (without limitation), for failure to comply with these Terms or if in the opinion of MND Victoria, acting reasonably, you represent a security risk, nuisance or annoyance to the running of an MND Victoria Event.
- b. You agree to comply with all instructions issued by MND Victoria or the operator of the venue for an MND Victoria event.
- c. You acknowledge that you may be filmed, sound recorded and/or photographed by MND Victoria, the media or any other party at the Event and MND Victoria may use or approve the use of the film, sound recording and/or photograph for any purpose and in any way whatsoever.

SAFETY AND WELLBEING

- a. Subject to these terms and applicable law, you are and remain responsible for your own health and safety at all relevant times, such as before, during and after any remote, off-site, online or virtual MND Victoria Events. You must ensure you are capable of participating, including being fit and healthy, eliminating anything hazardous or dangerous to your health, and being aware to stop if there are any health concerns.
- b. MND Victoria recommends informing friends and family of your intentions to participate and the details of any virtual or off-site route prior to participating in any MND Victoria Event and you agree to carry out all reasonable and necessary precautions in relation to your participating including but not limited to carrying a mobile phone, taking relevant medications and writing your emergency contact details down.

- c. You should seek medical advice to ensure you and/or any supervised minor are fit to participate. It is your responsibility to have suitable food and any medication that you require with you at all times.
- d. First aid will be available at all in person MND Victoria Events. Should you require ambulance transport to hospital it will be at your own expense.
- e. You accept responsibility at all times for personal belongings during an MND Victoria Event. Valuable items should not be left without supervision, as MND Victoria will not accept liability for loss or damage of personal belongings.
- f. Participants must adhere to any safety instructions given by the event organizers.

PRIVACY AND ONLINE SECURITY

- a. MND Victoria staff and volunteers understand and respect your right to privacy and the confidentiality and security of personal information provided by You. MND Victoria will take all reasonable steps to ensure that your personal information is protected from misuse, loss, interference and unauthorised access, modification or disclosure. You acknowledge that your personal information may be shared with others who are involved in the administration, management, insurance or delivery of the MND Victoria Event.
